Analysis of net assets	Fixed an issue with the PY difference check still showing under certain circumstances – even when there was no difference.	
Statement of Funds	The PY table will now hide if it is the first year of operation.	
Statement of Funds	The 'Total funds analysis by academy' section will now hide correctly when not required.
